Commissioner Broska would like us to use a different type of rock instead of trap rock. Commissioners Broska and Commissioner Byrd will be looking into different rock.

**Athletic Committee:** Ann Byrd reports that we have 71 Recreational baseball and softball teams, 9 select teams, and 213 coaches. Fields are being prepped, bags are ready, training dates set and camps coming up.

**Maintenance Supervisor:** Dave Qualls reports that maintenance crews are getting much on the playgrounds, fence for the grazing area for the animals will be put up this spring. We had the lake shocked to see what types of fish we need and will get a report soon. #10 restroom will be locked at 3pm due to vandalism and we will look into putting up a camera across from the restroom doors to try to catch the vandals.

**Office Manager:** Sandy Pensoneau reports that we are working on end of year, setting up a rodeo in the park and wrestling match at the Activity center. We are also looking into getting a liquor license for events that we hold in the park.
